## **OSC Rule 13-502 Fees Revocation and Replacement**

As we previously posted on February 10, 2015 the Ontario Securities Commission (“OSC”) approved the revocation and replacement of OSC Rule 13-502 Fees, Companion Policy 13-502CP Fees, OSC Rule 13-503 Fees and Companion Policy 13-503 CP Fees. These changes came into effect on April 6, 2015 and part of the changes include updates to the forms used to calculate the participation fees payable by reporting issuers. A copy of the OSC presentation on calculating fees can be found [HERE](#). In particular, slide 34 provides guidance on the applicable trigger date depending on the year end. Some of the changes to the form include:

- Eliminating the use of the reference fiscal year
- Addition of a management certification
- The addition of the use of “specified trading periods”

At the time of posting this information the OSC website had not been updated with the new 13-502 forms for download and use even though they are now in effect.
